A CHILD FRIENDLY COMMUNITY SELF-ASSESSMENT TOOL FOR COMMUNITY SERVICEPROVIDERS AND CHILD ADVOCATES

This tool is designed to assess the child friendliness of a community from the perspective of community service providers and child advocates. Local authorities that provide services to children in the community can also participate in this assessment. It asks questions about the context in which children grow, develop and experience their rights. As such, the tool is designed to supplement other data on children and their living conditions available to cities. Used in conjunction with the children's and adolescents' community assessment tools it can help guide the actions of communities and municipal authorities.


